Regis HR and Principal terminated the employee's employment on Oct. 31, 2022. The board and Principal reviewed if the complaint should be reported to FLDOE. Lisa Capote wanted to know if the defendant or parents were

satisfied with the action the school took. Ms. Navas stated there was a discussion with the parent and the parent was pleased with the termination of employment for the teacher. The board felt no reporting to FLDOE was necessary since it was a first occurrence by the teacher. This teacher did not have any other incidents while working at ACE.
